1. FOCUS

The LegalSoft focus is on supplying debt collection software to South African debt collectors.

2. WHO CAN USE THE SOFTWARE?

Whether you, the debt collector, are an attorney, a specialised debt collector or an in-house credit control department, this software has what you need to do the job professionally. LegalSoft gives you the competitive edge in this market.

3. DIFFERENT VERSIONS OF LEGALSOFT

All versions are network enable with remote log-in capabilities or can be used as stand-alone system.

3.1. Professional

This is a full range software package for debt collection. It incorporates all the required tools, functions, reports and process documents for the job.

3.2. Collector

This is a light weight scaled down version of the Professional version for use on remote sites.

3.3. Client Specific

The Professional version is the basis of this version, tailored and branded to the Client's requirements.

4. LICENSING

LegalSoft software is Proprietary licensed software, licensed under exclusive legal rights of the copyright holder. Licensing is per copy installed.

5. THE SOFTWARE

LegalSoft provides a vast number of user friendly functions and tools that cover all facets of the debt collection market.

5.1. File management

LegalSoft is a very user friendly software application that provides effective management of matter files vital to the success of all debt collectors. All functions and reports are available on a well-designed home screen that provides ease of access, speed, accuracy and effective user productivity.

5.2. Search function

Any data entered into the database can be search by this very efficient software search function, thereby giving the user quick, effective and accurate access to any matter file.

5.3. Diary

The software includes an electronic diary that assists users to effectively manage all matter files assigned to them. User defined system generated follow-up tasks are also entered into the diary.

5.4. Reminder system

The software has a reminder system that is set by the user for setting reminders for tasks for future dates.

5.5. Financial management

5.5.1. Cost tracking

Costs for documents, telephone calls, court processes, consultations, commissions and all other collection related expenses can be recorded in each debtor file and added to the final collection total amount.

5.5.2. Interest calculations

Interest calculations are system managed and calculated as provided for by the applicable laws of South Africa.

5.5.3. Suspense account

A suspense account function is included to enable the balancing of the Trust Account.

5.5.4. Distribution of collected funds

Distribution of collected funds is one of the most important functions of the debt collection business. LegalSoft software includes an accurate, effective time saving distribution reporting system.

5.6. Legal process

All processes in the software are as prescribed by South African Law. These processes can be categorised as:

5.6.1. Soft collections

This is the collection of outstanding debts whereby the collection process is suspended before the use of the court system is required.

5.6.2. Court process

This is the collection of debts from Final Demands through to Emolument Attachments or Writs of Execution. The legal process documents included cover the full spectrum of letters, notices, court documents and reports, etc. required for the collection process.

5.7. Document generation

All the documents referred to above are system generated using data from the database, entered into the selected documents in the correct position on the document.

5.8. Contact with debtors

Debtor contact is critical in the collection process; using the most effective and inexpensive methods are vital to the costs of the service.

5.8.1. SMS

SMSs can be sent and received via the software at below general market rates.

5.8.2. Email

Emails can be sent from the software.

5.9. Reports

All reports for effective management of the collection process, funds distribution, document tracking and third party management are available in the software.

5.10. Third party service provider management

Services and accounts from sheriffs, tracers, Section 58 signing agents, attorneys and other related parties can be managed with the LegalSoft software.

6. REMOTE ACCESS

The software can be accessed by secure remote access from anywhere where an internet connection is available. All the functions and tools of the software are available in the remote mode.

7. DOCUMENT TRACKING

Documents sent to the courts, sheriffs and Section 58 agents can be tracked, managed and reported on with the software.

8. BARCODE SCANNING FOR EFFICIENCY

Barcode scanning is included in the software. To use this very effective management tool, the user only needs a handheld scanner. User efficiency can be exponentially increased by the use of this barcode scanning.

9. TRACING SERVICES

LegalSoft software is integrated with a number of third party service providers, making the handing of instructions and the receiving of results quicker and more effective.
